Whereupon Mrs Lenora B. Elliott announced that she had sold to Alfred Budden all and every of the shares of stock she owns in said Incorporation to wit, 26140 Shares. And that she was about to assign said shares to said purchaser. He said Alfred Budden being present stated he desired to have Lenora B Elliotts stock by her assigned to him in smaller denominations than the certificate held by her called for. On motion of B F Mulkey seconded by Lenora Stead it was ordered that that said certificate of stock be called in and in lieu thereof she be authorized to receive and the Corporation be authorized to issue to her certificates of smaller denominations to suit the convenience of the said purchaser in an aggregate

And it being noted that Lenora B. Elliott had pursuant to the above authorization transferred said shares and each of them to Alfred Budden their purchaser and the said transfer was duly ordered and entered of record as a part of the transactions of this meeting ^{and transfers of stock noted}

Lenora B. Elliott thereupon submitted her resignation as president of the Pacific Chiropractic College, Inc. which resignation was duly accepted. The office of President being vacant and Alfred Budden now being a stockholder and the owner of 76140 shares of stock in said Corporation participated in the further deliberations of the meeting and on motion of B J Mulkey seconded by Lenora Stead Alfred Budden was duly elected president he having received a unanimous vote of all the stock present and voting in the number of 76190 Shares.

It was further declared on motion duly made and seconded that hereafter all checks drawn on the funds of the Pacific Chiropractic Incorporated shall be signed "Pacific Chiropractic College."
