Dear Doctors:

Enclosed please find a form of proposed Findings of Fact, Conclusions of Law and Consent Order in the aboveentitled and numbered matter.

The proposed order, which the college has agreed to, would find that the application of WSCC for approval by the Board, contained untrue statements of material fact or omissions of fact; that WSCC failed from June 11, 1977 through January 8, 1979 to offer a 4000 actual classroom hour curriculum; the curriculum in certain respects was deficient; and, that the college failed to notify the Board.

Further, the order would withdraw the accreditation and approval of WSCC, provided that imposition of withdrawal of accreditation would be deferred for a period of three (3) years, provided WSCC files reports with the Board every six months detailing any changes in curriculum, in-class and out-of-class hours; how the curriculum exceeds 4000 class hours; how the curriculum meets the specific chiropractic and science subject requirements of the Board's rules; as well as changes in faculty, administration or in administrative organization.

Further, the college must file its CCE reports and any audited financial statements to the Board; answer such interrogatories as the Board may direct; and, make itself available for on-site inspections by the Board.

Last, Western States Chiropractic College must for three Years certify in writing by its registrar that each applicant in Washington has completed a course of instruction in excess January 28, 1980 Page -2-

of 4000 classroom hours, including elective courses taken. The order does not require the Board to have a certification of nonattendance by reason of illness, family bereavement,

If this meets with your approval, please so resolve by motion and I will notify the college to execute and return the original to be signed by the Board.

If the Board desires to continue this matter, Joanne has the original of an Order of Continuance.
