Gentlemen:-

The records of this office indicate that your corporation income and excess profits tax return is delinquent for the calendar year 1938.

Under the law, every corporation is required to file returns from the date of incorporation to the date of definite abandonment or dissulution, notwithstanding the fact that no business was transacted or income received.

The officers of a corporation who fail to file a return or pay the tax, are liable to penalties for such failure. Section 145(a) of the Revenue Act of 1938 provides that any person required to file the return, who wilfully fails to do so, shall, in addition to other penalties provided by law, be guilty of a misdemeanor, and upon conviction thereof be fined not more than \$10,000.00 or imprisoned for not more than one year. These provisions also apply to receivers upon whom the law imposes the duty of filing the return in lieu of the officers of the insolvent corporation.

Unless your records show that the return was filed previously, kindly file it within ten days from the date of this letter, and attach thereto a statement on the enclosed form showing the reasons for delinquency. A letter in lieu of a return is of no value. Statements relative to the income, activities, or abandonment of the corporation, should be written across the face of the return.
